POSITIVE PROFIT ALERT

This announcement is made by AV Promotions Holdings Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) pursuant to Rule 17.10 of the Rules Governing the Listing of Securities on GEM of The Stock Exchange of Hong Kong Limited (the “**GEM Listing Rules**”) and the Inside information Provisions (as defined in the GEM Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

The board (the “**Board**”) of directors (the “**Directors**”) of the Company would like to inform the shareholders of the Company (the “**Shareholders**”) and potential investors that, based on the preliminary review by the Board of the unaudited consolidated management accounts of the Group for the nine months ended 30 September 2023 (“**9M2023**”) and the information currently available, the Group is expected to record a profit attributable to the owners of the Company for 9M2023 of not less than approximately HK\$7 million, as compared to the loss attributable to the owners of the Company for the nine months ended 30 September 2022 (“**9M2022**”) of approximately HK\$34 million.

Based on the information currently available, the Board considers that such expected profit of the Group for 9M2023 as compared to the loss for 9M2022 was mainly attributable to the substantial increase in revenue due to the resumption of events in Hong Kong and the People’s Republic of China as a result of the gradual lift of the anti-epidemic measures.

The information in this announcement is only based on the information currently available to the Board and the preliminary review of the unaudited consolidated management accounts of the Group for 9M2023 by the Board and may be subject to adjustments. The unaudited consolidated management accounts of the Group for 9M2023 have not yet been finalised and the information in this announcement has not been reviewed by the audit committee of the Company, and has not been audited or reviewed by the auditor of the Company. The actual third quarterly results of the Group for 9M2023 may be different from the information disclosed in this announcement. Shareholders and potential investors are advised to read carefully the Company's third quarterly results announcement for 9M2023, which is expected to be published on or around 10 November 2023 in accordance with the GEM Listing Rules.

Shareholders and potential investors are advised to exercise caution when dealing in the shares of the Company.
